



Update Nickie Aiken MP

Video conferences – Nickie has been keeping us up to date with how Westminster is coping with the Covid-19 virus. She holds a weekly video conference with some 20 amenity societies and residents associations in her constituency joining in. This enables the community to exchange information and raise issues directly with her and discuss matters of concern. This helps us get to know the other organisations as well, and creates a great feeling of community and common purpose.

At our video conference on 28th April we discussed a wide range of matters and Nickie updated us on others. The subjects included testing, domestic abuse, child protection, supporting business, keeping our pavements safe, theatres, changes that would be needed in relation to transport, and begging around supermarkets. She also confirmed that the government has now closed a loophole which enabled landlords to bankrupt businesses.

Food deliveries - Nickie has published on her website details of grocery and food deliveries within the City of London and Westminster. Do look at Nickie's website as she lists 21 suppliers of fruit, vegetables, groceries, meat and fish. The link is: www. nickieaiken.org.uk/groceries-and-fooddelivery-cities-london-westminster. It is so important that the elderly and vulnerable have access to food as well as the rest of the community.

Rough sleepers – As a previous leader of Westminster City Council, Nickie was very aware of the problems of rough sleepers. Westminster has almost the highest rate of rough sleeping anywhere

in the country. It was her priority to help them into accommodation and ensure the council services were adequate. She initiated Hidden Network Scheme to help. Many come here because they know the services are so good, and only 3 per cent actually are from Westminster. WCC and the City of London Corporation have successfully sourced temporary accommodation for the vast majority of rough sleepers. About 130 in Westminster refuse accommodation. The continuing concern is for the welfare of the rough sleepers but also to meet the high costs. WCC is concerned to ensure that the additional costs will be fully met by central government. Nickie has written to Robert Jenrick, the Secretary of State responsible, to ask for his confirmation.

Coronavirus scams – It is difficult to believe. but criminals are preying on the vulnerable for their own financial gain. A number of different scams have been reported to the police and some of them are incredibly convincing and sophisticated. Nickie warns us all to watch out for anything which seems too good to be true, as it is likely to be a scam. Take no risks and ignore anything coming from a source you do not know. If in doubt, do nothing.

e all know the Pantechnicon in Motcomb Street, but we do not know much about its history. I have often wondered and checked with that fountain of all knowledge, Wikipedia, but there is very little there to give any real idea about it.

The Belgravia Society is sent copies of planning applications and the results of any appeals. One such appeal arrived by email this week and, with the benefit of the inspectors' review, a small undated volume which mentioned the Pantechnicon, I am able report the history of the building.

The Pantechnicon was built about 1830. It was used for the sale and warehousing of carriages and the storage of furniture and other goods including table silver and other valuables. Many houses in Belgravia were locked up for much of the year, the owners coming to town

in about March and leaving again in July. Accordingly, their carriages were stored there; they were hauled into a long gallery, about 200 yards deep, until their owners returned for the London season.

Rates were set at about three shillings for a four wheeled carriage and 2/6 for phaetons. Should the owner wish to sell the carriage, a 5% commission was charged by the proprietor, Mr Seth Smith.

The front of the Pantechnicon has two large, arched entrances at street level, originally designed to give access for the carriages. The façade is formed of ten giant Greek doric columns. The inspector described it as "... informed by classical design principles of symmetry and proportion, has an impressive and dramatic presence within the relatively intimate confines of Motcomb Street".

The Pantechnicon continued



It was claimed that the building was fireproof, however, while the façade survived, the rest of the building was destroyed by fire in 1874. It was rebuilt and altered in the same year.

The firm continued to operate until 1967 when it moved to Parsons Green. The building was listed in 1958 and planning permission and listed building consent were granted in 2016 for various alterations and internal changes in association with mixed retail, restaurant and bar use.

A planning application was for two metal flagpoles that would extend diagonally into the street at an angle to the façade which would measure nearly 12 feet long and fixed just below the second storey window sills.

The inspector concluded, "The scale and the projecting nature of the flags and flagpoles would form dominant and unwelcome additions to the front elevation which would detract and distract from the architectural quality and aesthetic appeal of the listed building". He also said they would be "overdominant" and provide "visual clutter". He dismissed the Appeal.

We can rejoice then that the Pantechnicon has been protected and we will continue to enjoy it as it is, and not be dominated by wholly inappropriate advertising flags.

The Belgravia Society supports the democratic goal of the Neighbourhood Forum to create a truly local plan for Belgravia, **Dennis Wheatland**, Chairman of the Forum, asked us to publish the following letter to update you on the current activities of the Forum. In addition, you should put the date of the annual general meeting in your diaries now.

Dear Members

Can I start by sending you my best wishes and hoping that you are taking care and obeying government instructions to ensure that we beat Covid-19 as quickly as possible. Can I remind you that if any of you require help in any way as a result of the impact of Covid-19, please contact the Westminster Connects team by phoning 020 7641 1222 or emailing westminsterconnect@ westminster.gov.uk.

Turning now to the activities of the Belgravia Neighbourhood Forum (BNF), I can tell you that during last summer the Forum completed the initial stage of consultation with the residents and the businesses of Belgravia, but then faced the need to seek the re-designation of the Forum from Westminster City Council. I am delighted to say that this re-designation has now been received and I would like to pass my thanks to all those members - and I know there were many – who took the trouble to write to the Council to support the re-designation of our Forum. We now have a five-year period within which to complete and secure approval of the Neighbourhood Plan for Belgravia.

I am pleased to tell you that we have also been successful in gaining some initial funding from WCC to engage a professional consultant to help us in drafting the Plan, and work is currently underway on this. However, the combination of the process required to obtain the re-designation, this funding, and the constraints imposed by Covid-19 has resulted in the timetable we had envisaged slipping by some six months.

You may have on your calendar a date in May for the Forum Annual General Meeting. Given the current circumstances, it will not be possible to hold that meeting as planned. It has therefore been decided, as is permitted under the constitution of the BNF Ltd. that this meeting will be held later in the year. So please note a new date for the AGM of Thursday 14th September. The meeting will also include a presentation of progress on the BNF Plan. You will receive a reminder closer to the date of the AGM. Please make a real effort to attend this important meeting.

Our overall target remains to hold an open meeting later in the year for a presentation of the draft Plan; this meeting will be open to all residents and businesses of Belgravia.

You will all be receiving emails from WCC on a daily basis updating you on what is going on in the city. We are being given daily information on all aspects of the lockdown and how the WCC is tailoring its services to the needs of communities throughout Westminster as well as responding to issues raised with them.

In addition, the Leader of the Council, Councillor Rachael Robathan, is holding fortnightly video conferences with amenity societies and community groups in order to hear what is happening in different parts of the city. Information is therefore immediately available to WCC about the needs of the communities, problems arising on a day-to-day basis and also answering questions where possible. Many points are taken back by Councillor Robathan to be dealt with.

Waste collection and cleaning teams are working round the clock to keep the city clean whilst, at the same time, following safe working practices and social distancing rules. It is providing Supporting Businesses Podcasts, advising on business grant status, keeping us informed on public health, dealing with the homeless and finding shelter for them as well as creating and expanding support to the community generally through its Westminster

Connect Scheme. Almost 3,000 volunteers have registered to help. This link will take you to the WCC webpage showing organisations and shops that are available to residents:

Although libraries are closed, special areas in Victoria libraries have opened up to help residents that do not have their own computers or access to the internet.

In response to the Covid-19, The City of Westminster Charitable Trust has launched a new Covid-19 grant scheme. It is part of the Community Contribution which was created by Westminster to give residents in the top council tax bands the opportunity to give more to their local community on a voluntary basis. This scheme will give up to £15,000 for organisations operating in Westminster to provide extra support to help rough sleepers off the street or keep them protected during the outbreak, provide youth support or offer support to people who are suffering from social isolation or loneliness.

The above is only a fraction of the work which WCC is carrying out as well as their usual obligations. We congratulate councillors and officers of WCC for their incredible work during this difficult time.

report on local shopping

Sadly, **Charles** in Lower Belgrave Street has closed temporarily



PC Dave Alford reports

During the lockdown period so far we have seen a drop in the amount of reported crimes on the Knightsbridge and Belgravia Ward. As you know, this is due to a low footfall and all of the shops, excluding Sainsbury's and Waitrose, being closed. This has unfortunately caused a slight increase in the amount of beggars and rough sleepers being found near the open stores.

While speaking with a few of the homeless community, it was established that some have been dropped by their former employers and left to fend for themselves. We have a number of Romanian nationals that were employed and have now no way of getting home. The team have pointed them to Outreach services which, from what I understand are stretched.

The stores and coffee shops (takeaway only) that are open have been visited two or three times a day by us. The customers are being managed well and there have been no major

issues reported. Fortunately, we haven't encountered any major issues with residents not complying with the Lockdown Guidelines, no fines have been issued by us so far and I find that friendly words of advice get the desired effect.

A question was asked by one of my response team colleagues regarding the private gardens and people using them to picnic or sunbathe. The issue we have with these is that they are technically residents' gardens and our powers are somewhat restricted unless we find large groups from different families mixing, proving this is another issue.


As I mentioned before, most people comply with our directions which is better than having to issue fines, etc. As community officers, we rely on support from our community and at the moment there seems to be no end of support not only to us, but to all frontline services.

The Walbrook Club

↑ Ithough the Walbrook Club is in the City of London, we felt in these uncertain times it would be good to show solidarity. There are two distinct cities in London, City of Westminster and the City of London. Although there are huge differences between us, we have two distinct things in common. In normal times, tens of thousands of commuters arrive in our cities for their daily work. The second is that we are in the same Parliamentary constituency and share our MP, Nickie Aiken, with them.

Nestled amongst the gleaming high-rise towers of the City of London stands a Lilliputian Queen Anne-style townhouse. It was originally built by the late property magnate, Rudolph Palumbo, in 1952 as his family office. The building itself is as improbable as it is charming. Such is its uniqueness, it has affectionately been described as "Glyndebourne in the City". It is home to The Walbrook Club. Opened in May 2000, the Club does have a strict dress code as one would expect for one of its quality. In normal times, it is open throughout the day from Monday to Friday with breakfast from 7am, lunch and then dinner until late.

Its conversion into a private members' club was overseen by the doyen of London clubs, Mark Birley, of the original Annabel's, Harry's Bar and Mark's Club. The Club is located directly next door to the Mansion House and NM Rothschild, and is the only expression of Birley's genius outside of Mayfair. Albert Roux of Le Gavroche set up the kitchens whilst Steven Spurrier created the wine list.



Development and building sites

ast month we reported on a number of building sites in the area being shut as a result of the lockdown. This was done voluntarily and the government did not require them to close. Most of the sites have reopened but with a change to working practices designed to support social distancing and stop Covid-19 spreading.


Chelsea Barracks – we are advised that the site remains open but for limited work. Mace, who are finishing phase 3, will be leaving the site soon in any event. Multiplex continue with phase 4.



33-39 Knightsbridge - the contractors are continuing to operate on site with a number of safety measures for their protection including segregated working zones and other appropriate precautions. Work therefore continues.

55-91 Knightsbridge – liaison meeting took place via video on 7th April, but no more are scheduled at the moment owing to Covid-19. The site remains open and, as far as possible, work will continue including main roof construction, 3 and 4 William Street roof coverings, lift installing and testing, and various fit-outs internally, plus continuation of other works.

The dismantling of the final tower crane has been postponed due to TfL requirements to maintain a clear route between London hospitals.



Cundy Street – there is no specific news yet, however, we do expect to hear something from Grosvenor very shortly and will report to you in next month's Magazine. We remain deeply concerned about the proposed heights of the buildings.

our local councillors are busy in their wards helping and supporting residents and businesses and much occupies them. They continue to provide whatever support or advice is needed and will continue to do so in the coming weeks.

They have had many offers of help. They reiterate that if constituents need assistance or have concerns about a vulnerable neighbour or relative, then they can be best served by contacting Westminster Connects Team by email, or telephoning 020 7641 1222 from 8am-7pm, seven days a week.

Some WCC services, libraries, leisure centres and playgrounds, following government advice, have been closed. However, such essential services as refuse collection and street cleaning services are fully operational. The Council is moving resources around as more people are working from home in residential areas of the City.

The Council is providing NHS workers and care workers with free parking on their pay-by-phone bays throughout the City for any period of time; they just need to

show appropriate NHS credentials on their windscreens.

Your local councillors are there to support everyone in the community. They are there for you and you should not hesitate to contact them. As usual, full details are given in this Magazine on page 20.

Councillors from Warwick Ward also give us news affecting their Ward. The councillors have been receiving complaints from residents relating to antisocial behaviour, including drug taking and drinking at the back of offices at 11 Belgrave Road. Councillor Wilkinson has been working with the developer who has offered 50% of the funding for new hoarding to prevent access and the remainder of the cost is being be met by the current landlord.

Councillor Wilkinson, who is also Westminster's Animal Welfare Champion has told us that dogs must now be kept on leads. "Social distancing is a crucial tool for staying safe, so dogs must remain close to their social distancing walkers and avoid unexpected contact".

Postscript from WCC


n 26th April 2020 the Environment Secretary, George Eustice, set out how food suppliers have been addressing the supply of groceries while the nation remains in lockdown.

He reported that:

- Staff absence due to self-isolation and illness has dropped significantly in food suppliers, from 20% earlier in the lockdown to less than 10% at the end of last week.
- 500,000 food parcels have been delivered to people with medical conditions which require them to be "shielded" indoors for 12 weeks.
- Supermarkets have carried out 300,000 priority deliveries to these groups.
- Supermarkets have increased delivery slots from 2.1 million to 2.6 million a week, and intend to add a further 300,000 over the next couple of weeks, although he acknowledges this will not be enough to meet all the demand.

Prof Stephen Powis, the National Medical Director of NHS England, said that the benefits of social distancing were clearly showing, with the number of hospital admissions and critical care beds in use both declining.
